# Your pension has been increased by 3%

Good news: your accrued pension has been increased by 3% as of 1 January 2023. This was decided by VLEP's board.

"Everyone with our fund will get 3% more", says employee chairperson Ilse van Eekelen. "We are happy that we are finally able to do this again after so many years. However, we are aware of the fact that prices of groceries and energy, for example, have risen more steeply. We should therefore be cautious, because there will be a new pension scheme in 2025. We want to have enough cash on hand for that."

### Your pension in 2023

How much pension contribution do you and your employer pay in 2023? How much pension do you accrue? And on what portion of your salary? The answers to those questions are set out below.

- In the Meat industry, the pension contribution in 2023 is the same as in 2022. In the three other industries, the premium has increased slightly. Please see your payslip for the premium you pay.
- The accrual rate has increased in all industries.
- The "threshold" has gone up in all industries. The threshold was EUR 13,518 in 2022 and has gone up to EUR 13,913 in 2023. You do not accrue pension and do not pay any pension contributions on that portion of your salary.




## Ensure that you do not lose your pension!

### New rules for pensions

We have come one step closer to the new pensions act. The Dutch House of Representatives passed the legislative proposal on 22 December 2022.

## What happens next?

Now it is up to the Senate. If the Senate also passes the legislative proposal, it is expected that the new Future Pensions Act will enter into effect on 1 July 2023.

#### Nothing will change for you yet

That will not happen until the new pension scheme enters into effect. We hope to switch on 1 January 2025. We will keep you informed about further steps.
